Pursuant to the Charter of Nam A Commercial Joint Stock Bank as amended and supplemented and approved by the General Meeting of Shareholders on March 20th, 2026;

Pursuant to Decision No. 1642/2024/QĐQT-NHNA dated October 28th, 2024 of the Board of Directors on the promulgation of the Regulation on organizational structure, management and administration of Nam A Commercial Joint Stock Bank;

Pursuant to the Resolution of the 2026 Annual General Meeting of Shareholders dated March 20th, 2026 of Nam A Commercial Joint Stock Bank;

Pursuant to the Resolution No. 875/2026/NQQT-NHNA dated April 21st, 2026 of the Board of Directors regarding the approval of the List of employees eligible for the allocation of rights to purchase shares under the employee stock option program of Nam A Commercial Joint Stock Bank in 2026;

Pursuant to the Minutes of Meeting No. *1352*/2026/BBH-NHNA-BĐHESOP2026 dated June *16th*, 2026 of the ESOP Executive Board on the results of the allocation of shares under the employee stock ownership plan of Nam A Commercial Joint Stock Bank for 2026;

Pursuant to the Approval of voting of the members of the Board of Directors;

Pursuant to the Power of Attorney No. 806/2026/UQQT-NHNA dated April 10th, 2026 of the Chairman of the Board of Directors authorizing the Vice Chairwoman of the Board of Directors – Mrs. Vo Thi Tuyet Nga.

HEREBY RESOLVES:

Article 1. To approve the results of the share allocation under the Employee Stock Ownership Plan of Nam A Commercial Joint Stock Bank in 2026, with details as follows:

- Share name: Shares of Nam A Commercial Joint Stock Bank.
- Type of shares: Ordinary shares.
- Number of shares prior to the issuance: **2,058,822,282 shares** (*Two billion fifty-eight million eight hundred twenty-two thousand two hundred eighty-two shares*), corresponding to a charter capital of **VND 20,588,222,820,000** (*Twenty trillion five hundred eighty-eight billion two hundred twenty-two million eight hundred twenty thousand Vietnamese dong*).

- Total number of shares expected to be issued: **100,000,000 shares** (*One hundred million shares*).
- Number of shares allocated to employees: **100,000,000 shares** (*One hundred million shares*), representing 100% of the total number of shares expected to be issued.
- Number of employees allocated shares: **1,775 employees**.
- List of employees registering and paying for shares as set out in the attached Appendix.
- Completion date of the issuance: June 15th, 2026.
- Number of shares after the issuance: **2,158,822,282 shares** (*Two billion one hundred fifty-eight million eight hundred twenty-two thousand two hundred eighty-two shares*), corresponding to a charter capital of **VND 21,588,222,820,000** (*Twenty-one trillion five hundred eighty-eight billion two hundred twenty-two million eight hundred twenty thousand Vietnamese dong*).
- Upon completion of the issuance and upon receipt of written approval of the issuance results from the competent state authorities, any excess payments, late payments, or other applicable cases shall be refunded to employees in accordance with applicable regulations.

Article 2. The Chief Executive Officer – Legal Representative is assigned to carry out the relevant procedures to complete the share issuance for the increase of charter capital in 2026 in accordance with applicable laws and the Charter of Nam A Commercial Joint Stock Bank.

Article 3. This Resolution takes effect from the signing date.

Members of the Board of Directors, the Board of Supervisors, the Board of Management and relevant organizations, individuals are responsible for the implementation of this Resolution./.
